

SUBJECT: Declaration of Conformity to the REACH Regulation, concerning the presence of Substances of Very High Concern (SVHC). Update of the Candidate List (SVHC) dated November 5, 2025.

The REACH Regulation (Registration, Evaluation, Authorisation and Restriction of Chemicals) is periodically updated. The latest relevant amendment to the ECHA **Candidate List** took place on **November 5, 2025**, with the addition of new Substances of Very High Concern (SVHCs), including **1,1'-(ethane-1,2-diyl)bis[pentabromobenzene] (DBDPE)**. With this declaration, Trancerie Emiliane S.p.A., in reference to Regulation (EC) No 1907/2006 concerning the registration, evaluation, authorisation, and restriction of chemicals (REACH).

WHEREAS

- The REACH Regulation, which entered into force on June 1, 2007, establishes rules for the management of chemical substances, implying the necessity of communication between customers and suppliers of substances, preparations, and articles that they sell and purchase;
- Trancerie Emiliane S.p.A. qualifies as a **Downstream User** of substances/mixtures, products manufactured within the European Union.

DECLARES THAT

- The company is not categorized as a producer/importer of substances under the REACH Regulation and is therefore not required to register or pre-register the substances it uses in its production process;
- The supplied articles are not subject to the provisions of the REACH Regulation as they cannot be qualified as "articles intentionally releasing substances";
- **Based on our knowledge and the information provided by our supply chain, Trancerie Emiliane S.p.A. does not intentionally add or introduce any substance listed in the ECHA *Candidate List* into its articles.**
- A mutual exchange of information is maintained with all suppliers, to verify their position with respect to the REACH Regulation and any restrictions provided for by Annex XVII of the Regulation;
- **None of the articles supplied by us contain any Substance of Very High Concern (SVHC) included in the *Candidate List* (including the update of November 5, 2025) or in Annex XIV of the REACH Regulation (1907/2006/EC) in a concentration above 0.1% by weight (w/w).**

We hereby declare that **all articles supplied by us** are fully compliant with the REACH Regulation.
