





## **RoHS III DECLARATION**

## Ref. Directive 2015/863/EU RoHS III

Object: Delegated directive (EU) 2015/863 OF THE COMMISSION of March 31, 2015 amending Annex I of Directive 2011/65 / EU of the European Parliament and of the Council as regards the list of substances with usage restrictions

TRANCERIE EMILIANE S.p.A declares that all the details supplied to your company are produced in compliance with the RoHS III DELEGATE DIRECTIVE (EU) 2015/863 OF THE COMISSION of March 31, 2015 amending the Annex II of the directive 2011/65/EU of the European Parliament and the council regarding the list of substances with usage restrictions.

## THE PRESENT DIRECTIVE HAS ADOPTED:

Annex II of Directive 2011/65 / EU is replaced by the text of the Annex to the present Directive.

Article 2

1. By 31 December 2016, Members shall adopt and publish the legislative, regulatory and administrative provisions necessary to comply with this Directive. They shall immediately communicate the text of those provisions to the Commission; these provisions shall be applied from 22 July 2019. When the Members adopt these provisions, they shall contain a reference to this Directive or be accompanied by such a reference on their official publication. The method of this reference is decided by the member states.

2. Member states shall communicate to the committee the text of the essential provisions of domestic law adopted in the field governed by this directive.

Article 3

This directive enters into force on the twentieth day following its publication in the official journal of the EU.

Article 4

This directive is addressed to the member states.

Annex II substances with restrictions of use referred to in Article 4, paragraph 1, and values of maximum concentrations tolerated by weight in homogeneous materials:

lead (0.1%) Mercury (0.1%) Cadmium (0.01%) Hexavalent chromium (0.1%) Polybrominated biphenyls (PBB) (0.1%) Polybrominated diphenyl ethers (PBDE) (0, 1%) Bis (2-ethylhexyl) phthalate (DEHP) (0.1%) Benzyl butyl phthalate (BBP) (0.1%) Dibutyl phthalate (DBP) (0.1%) Diisobutyl phthalate (DIBP) (0.1%), the restriction concerning DEHP, BBP, DBP and DIBP applies to medical devices, including in vitro medical devices, and to monitoring and control tools, including industrial monetary and control instruments, from 22 July 2021. The restriction concerning DEHP, BBP, DBP and DIBP does not apply to cables or replacement prices destined for repair, re-use or updating of features or capacity of AEE marketed before 22 July 2019, and medical devices, including in vitro medical devices, monitoring and control tools, including industrial monitoring and control tools, marketed before 22 July 2021. The restriction concerning DEHP, BBP and DIBP does not apply to toys that are already subject to the restriction relating to DEHP, BBP, and DBP referred to in Annex XVII, item 51, of Regulation (EC) No. 1907/2006.»
