



REACH DECLARATION

REF. REGULATION (EC) No 1907/2006 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL OF 18 DECEMBER 2006 CONCERNING THE REGISTRATION, EVALUATION, AUTHORISATION AND RESTRICTION OF CHEMICALS (REACH)

Trancerie Emiliane Spa declares, in relation to the fulfillment of the obligations provided by the European reach regulation, that being a downstream user of substances, mixtures, and manufacturer of articles not intended to release substances during foreseeable use, is not subject to the preregistration and registration obligations of substances intended for producers and importers of substances and articles intended to release substances during use.

Trancerie Emiliane Spa has therefore endeavored to fulfill its obligations, namely:

- check with their suppliers whether the articles supplied contain SVHC substances from the "candidate list" above the legal threshold (0.1% w / w).
- Check with their suppliers that all substances as such or present in mixtures subject to REACH have been, by their registered or pre-registered suppliers, according to the REACH Regulation.
- verify that the substances used in the manufacture of their products are used within the conditions of use provided for such substances as they are or contained in mixtures.
- in the event of non-compliance with one of the previous points by a supplier, find valid alternatives in compliance with the REACH in order to guarantee the continuity of supplies.
- based on the information received to assess the presence of SVHC substances in the products supplied to the customer.

Trancerie Emiliane Spa therefore guarantees continuity of supply with regard to the products by you purchased and all products in its catalog and declares that they comply with the REACH Regulation.

Based on the knowledge currently in our possession, our products do not contain any of the "candidate list" SVHC substances listed in the list published by ECHA in concentration above 0.1%. If in the future SVHC substances of candidate list are found in our products in concentration or higher than 0.1% we will inform you in compliance with article 33 of the REACH Regulation.
